Notable Events of January 2015

Gold Bar

- The Gold Bar Post Office has installed video cameras to aid in deterring theft, following the three burglaries occurring Dec 24th to January 2nd. There was also one vandalism, graffiti, reported at the post office.
- Vandalism via graffiti has been reported at the rental storage and grocery stores as well. The school resource deputy is assisting with these investigations.
- Four thefts were reported, one for a license plate, one by fraud, and two thefts of mail from residential mailboxes. We also had three trespass complaints, two of which were solved by warrant arrest.
- There were six disturbance complaints with no assault. One was resolved by warrant arrest. Deputies made four warrant arrests total in Gold Bar, one of which involved repeated complaints on a subject who was ultimately arrested on a Chelan County warrant that was only valid for booking in Eastern Washington so that the deputies transported him over the pass to resolve the issue. One threat complaint was also reported.
- There were two domestic violence assault complaints, one of which was occurring in a moving vehicle that left Gold Bar and was ultimately stopped approaching the town of Lowell by a Gold Bar Deputy.
- Deputies responded to three controlled substance complaints, one of which was reported by a citizen who received an unsolicited package of marijuana via mail.
- Additional complaints: one death investigation, one collision, and one found property.
- Complaints cleared without a case report are not summarized above.

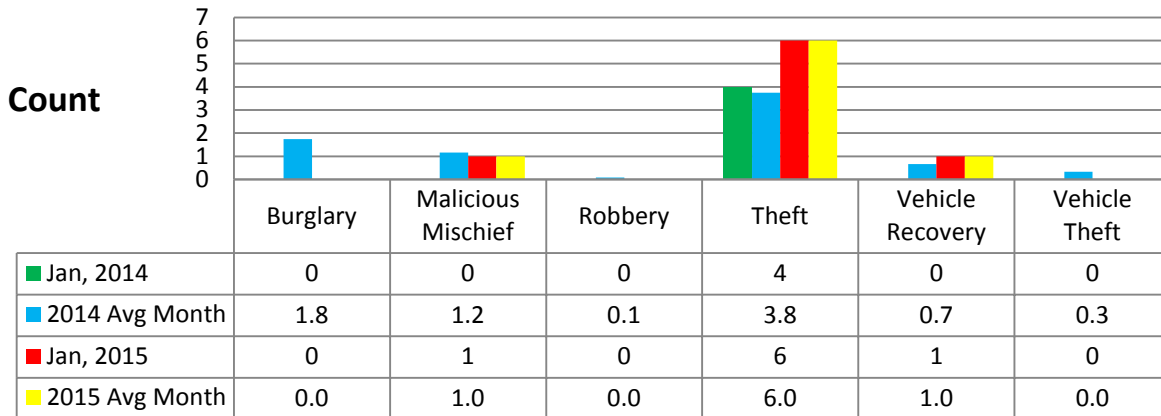
Index

- No incidents generating a police case report have been reported in Index. We were advised that the owners of the dog(s) responsible for several noise complaints late in 2014 have taken appropriate measures to remedy the problem.
- Note: The numbers above do not always match the numbers shown in the charts on the following pages, in part because the statistics below are pulled from dispatch records which do not always accurately reflect the final type for the service call. A deputy may respond to a suspicious circumstance and later change the type to theft, for example.

Data displayed is for all dispatch groups provided service by the Gold Bar Region (KK) and Index (RR) police agencies. All statistics may be viewed at Gold Bar City Hall.

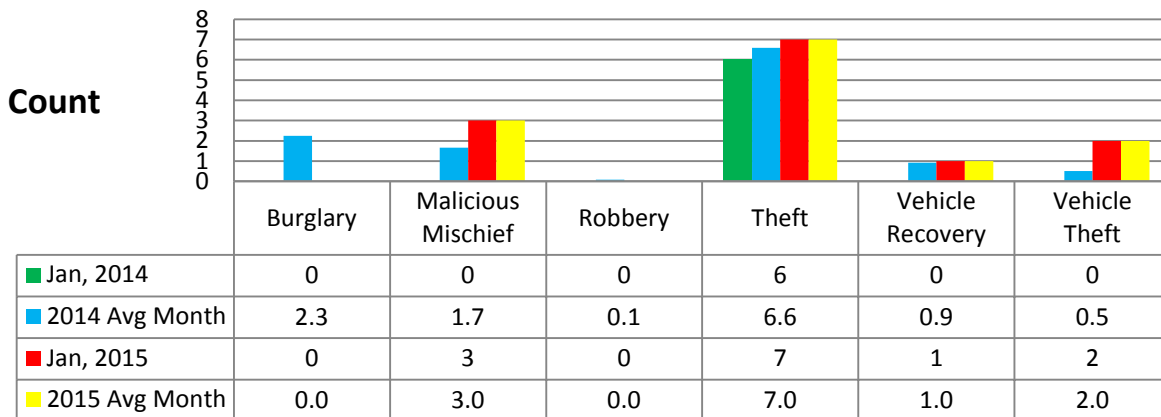
Property Crime - Gold Bar Region

Reports and Arrests Made



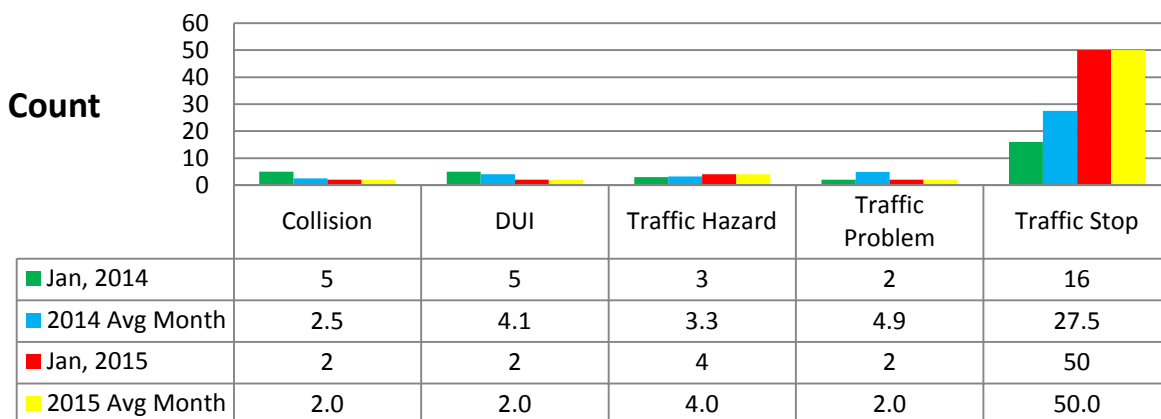
Property Crime - Gold Bar Region

All Dispositions

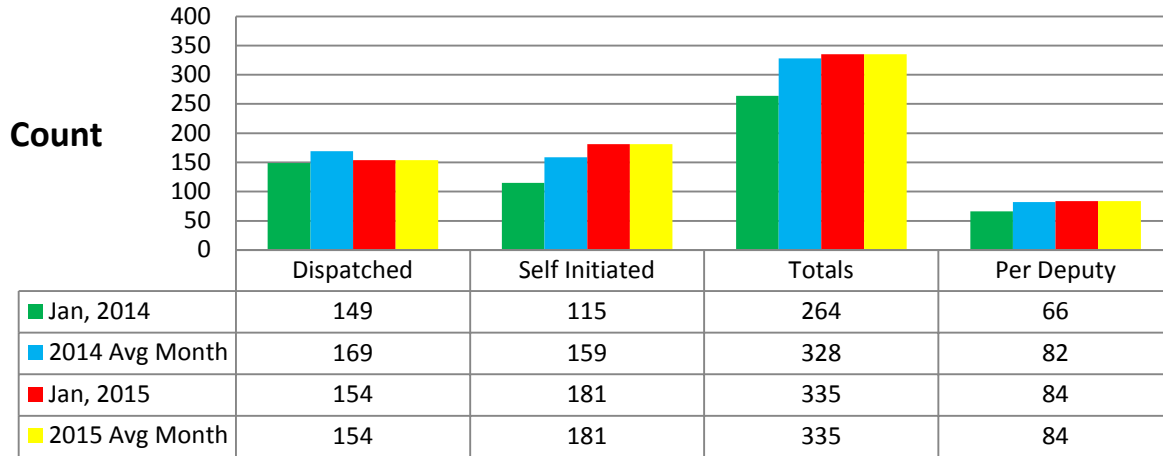


Traffic Calls - Gold Bar Region
