

Notable Events of April 2015

- Deputy Saint-Denis has been reassigned to the training unit for the Sheriff's Office. He is a professional trainer with years of experience as an instructor for law enforcement professionals, public speakers and professional and amateur sportsmen. Deputy Ron Doersch takes his place beginning Thursday, May 7th. Deputy Doersch was a Snohomish County deputy prosecuting attorney for nearly 30 years before joining the Sheriff's Office several years ago. He brings considerable expertise in criminal law, police tactics, and training.
- The Snohomish County Health Department began issuing Naloxone (Narcan) to Law Enforcement Officers. Several of the Gold Bar Region Deputies are now carrying this life-saving medication to treat persons who have overdosed on opioids such as Heroin, Oxycodone or Fentanyl. This is a fast-acting nasal spray that temporarily reverses the effect of opioids on the central nervous system and lasts long enough to get a person into the care of medical professionals.






