

**CITY OF GOLD BAR, WASHINGTON
ORDINANCE NO. 688**

AN ORDINANCE OF THE CITY OF GOLD BAR, WASHINGTON, AMENDING ORDINANCE NO. 669, SAID ORDINANCE BEING THE BUDGET OF THE CITY FOR THE FISCAL YEAR ENDING DECEMBER 31, 2015.

WHEREAS, general revenues and expenditures within fund 302 have exceeded budgetary estimates; and

WHEREAS, Ordinance #669 budgeted \$238,487 for the 5th Street Sidewalk grant; and

WHEREAS, Ordinance #669 did not include the city's portion of the 5th Street Sidewalk grant, and

WHEREAS, the city's portion of the 5th Street Sidewalk grant must be included; and

WHEREAS, the budget for 2015 did not budget additional expenditures and revenues from 2014 grants that were not closed in 2014; and

WHEREAS, it is necessary to amend the 2015 budget to authorize spending authority for fund 302;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GOLD BAR ORDAINS as follows:

Section 1. Budget

The budget for the City of Gold Bar, Washington, for the fiscal year 2015 as fixed and determined by the City Council at a public meeting on December 2, 2014, and as adopted by Ordinance No. 669, is hereby amended as set forth in detail and by reference.

Section 3. Amendment

Ordinance No. 669 is hereby amended to read as follows:

2015 Budgeted Revenue is amended from \$238,487 to \$277,217

2015 Budgeted Expenditures are amended from \$253,986 to \$277,217

This ordinance shall take effect from and after its passage, approval, and publication as provided by law.

Section 5. Severability

The ordinance is severable and if any portion of it shall be declared invalid or unconstitutional, the remaining portion shall remain valid and enforceable.
