



FENCE PERMIT APPLICATION & CHECK LIST

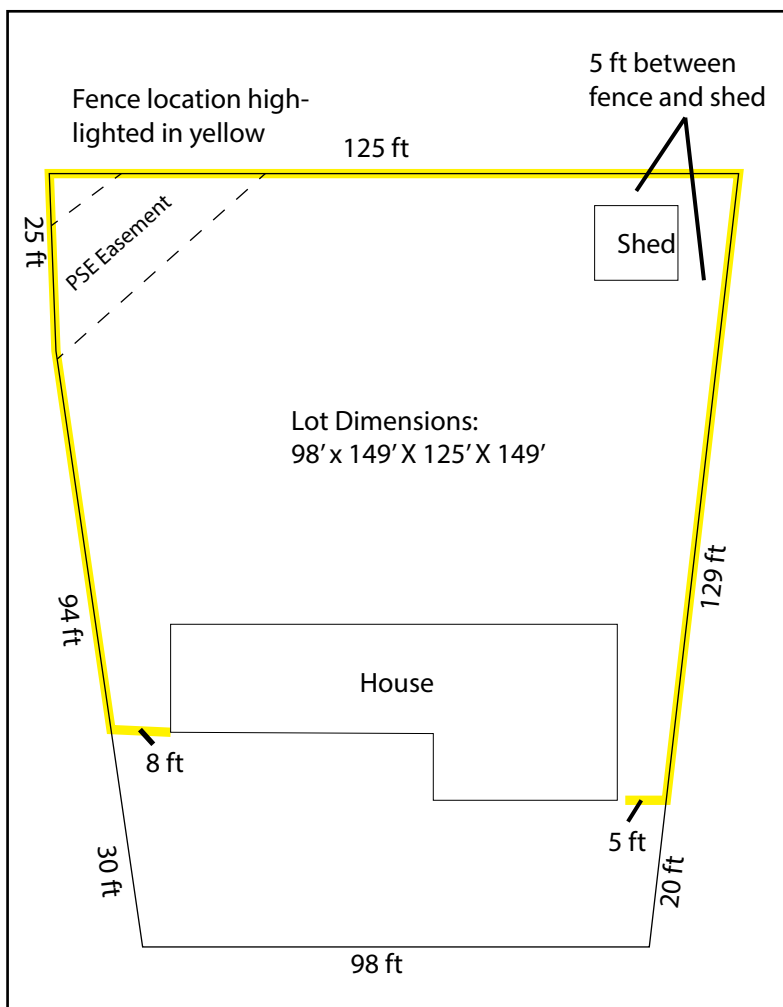
**Note: Fence application must be complete or it may not be accepted.
All information must be turned in at time of application submittal.**

The following is required for approval of our fence permit application:

- 1.) Completed fence permit application.
- 2.) Copy of site plan. Include lot size, any easements and location of existing structures. Linear feet between lot lines/structures and proposed fence. Proposed fence location and height. Description of fencing materials.
- 3.) Setbacks (Site must be staked)

**City of Gold Bar reserves the right to require other permits based on individual evaluation of each project.*

- 6 Foot tall cedar fence.
- 4 x 4 wood post set in concrete.
- 1 x 6 cedar boards.
- 4 Foot tall cedar fence section next to house.
- 4 x 4 wood post set in concrete.
- 1 x 6 cedar boards.

Your Site Plan is REQUIRED to be submitted with the application.

This permit may be revoked if the work is not in conformance with laws, rules and regulations of the City of Gold Bar. The duty to ensure conformance rests with the builder, developer and permit applicant, not the city. The approval of construction plans and satisfactory inspections do not guarantee that all provisions of applicable codes have been met. All plans submitted to the City become public record and are available for public inspection and copying. All contractors performing work authorized by this permit must be registered as required by state law and must have a current business license within the City of Gold Bar.
