

**CITY OF GOLD BAR, WASHINGTON  
ORDINANCE #761**

**AN ORDINANCE FOR THE CITY OF GOLD BAR, WASHINGTON, AMENDING THE 2022 BUDGET**

**WHEREAS**, Ordinance #754 set forth expenditures and revenue for the 2022 annual budget; and

**WHEREAS**, the Council for the City of Gold Bar recognizes the urgent need for a working dump truck; and

**WHEREAS**, the Council has discussed options for the purchase of a dump truck; and

**WHEREAS**, the City's Financial Plan sets guidelines for the use of beginning/ending balances for financial needs over and above normal operating expenditures; and

**WHEREAS**, the City's Financial Plan sets forth which funds may be used for such financial needs based on audit restrictions; and

**WHEREAS**, the purchase of a dump truck may require utilizing beginning/ending balances for some, or all, of the dump truck cost depending on revenue received during the year; and

**WHEREAS**, the purchase of a dump truck requires an amendment to the City's operating budget;

**NOW THEREFORE, THE COUNCIL FOR THE CITY OF GOLD BAR ORDAINS** that Gold Bar Municipal Codes shall be amended as follows:

**Section I, Budget**

The budget for the City of Gold Bar, Washington, for the fiscal year 2022, as fixed and determined by the Council at a public hearing on November 16<sup>th</sup>, 2021, and as adopted by Ordinance #754, is hereby amended as set forth in detail and by reference.

**Section II, General Fund (001)**

The General Fund is hereby amended to authorize additional expenditures of \$16,500.00.

**Section III, Street Fund (101)**

The Street Fund is hereby amended to authorize additional expenditures of \$24,800.00.

**Section IV, Water Fund (401)**

The Water Fund is hereby amended to authorize additional expenditures of \$20,700.00.

**Section V, Stormwater Fund (415)**

The Water Capital Fund is hereby amended to authorize additional expenditures of \$20,700.00.

**Section VI, Severability**

This ordinance is severable and if any portion of it shall be declared invalid or unconstitutional, the remaining portion shall remain valid and enforceable.

**Section VII, Effective Date**

This ordinance shall take effect from, and after, its passage, approval, and publication as provided by law.
