Monthly Report to the Community for May 2025

The Month in Numbers: 5/1 to 5/31/25

- 316 Incidents in the City of Gold Bar of which 150 were deputy initiated.
- 629 Incidents in the Gold Bar Region of which 281 were deputy initiated.
- **945 Incidents for the month of May.**
- **30 Incidents per day on average**

These incidents are being handled by a total staff of four Deputies and a Chief in an area of over 410 sq miles.

Highlights of the Gold Bar Police Department from this Month:

In May, the department remained busy averaging 30 calls for service (CFS) a day. These calls included the following:

On 5/14, Gold Bar deputies responded to a reported burglary in progress in the 200 block of Lewis Avenue. A juvenile was contacted and transported to area hospital for a mental evaluation by their parents. The case was referred to the Prosecutor's Office.

On 5/15, Gold Bar deputies responded to assist the King County Sheriff's Office on an assault with a weapon call in Skykomish. Upon arrival and after investigation, it was learned the incident was a disturbance. No weapon or weapons had been involved.

On 5/17, Gold Bar deputies assisted on a Search & Rescue incident on Reiter Road.

On 5/20, Gold Bar deputies responded to a theft in progress in the 31600 block of 160th Street SE, located in unincorporated Sultan. Upon arrival, the suspect vehicle fled from deputies. However, the vehicle was later located, and two individuals were taken into custody without further incident.

On 5/21, our Regional Bomb Squad was contacted to remove old blasting caps from the 100 block of Lewis Avenue

On 5/23, Deputy Wunningham contacted a passed-out individual in a running vehicle in Sultan. The individual was found to be in possession of 24 grams of heroin, 6 grams of cocaine, and 23 grams of fentanyl. A firearm was also seized.

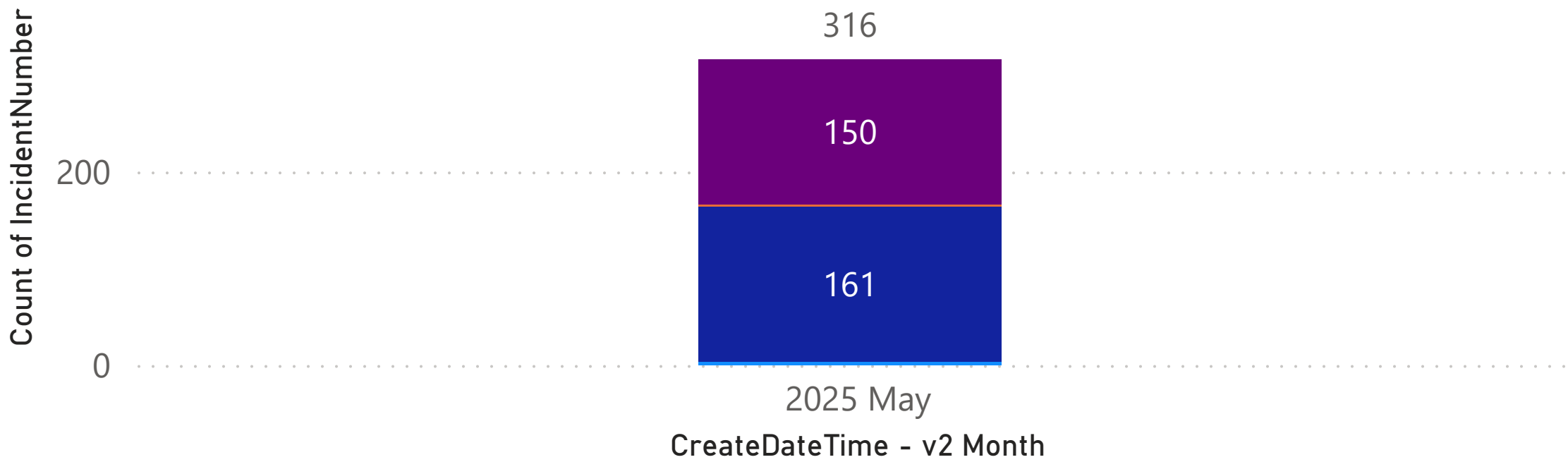

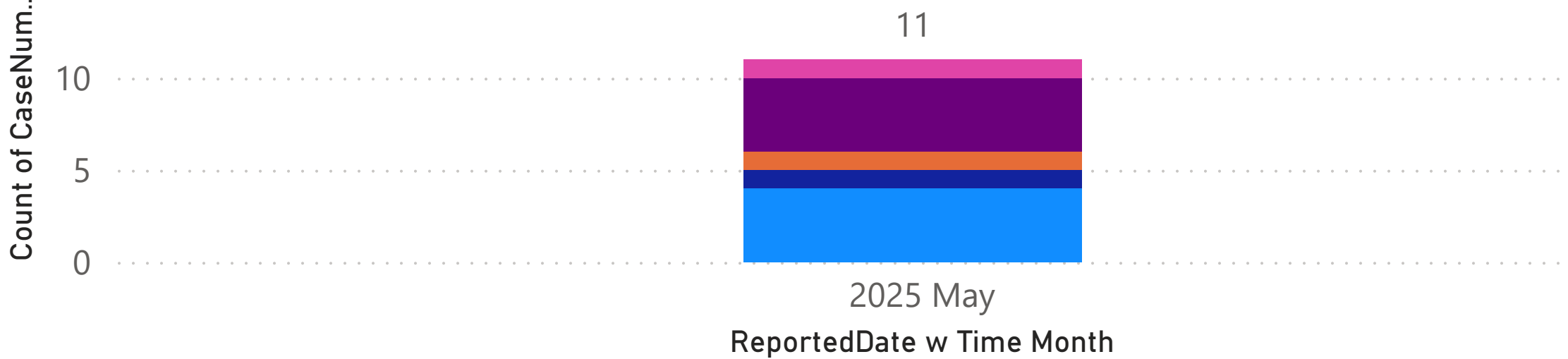

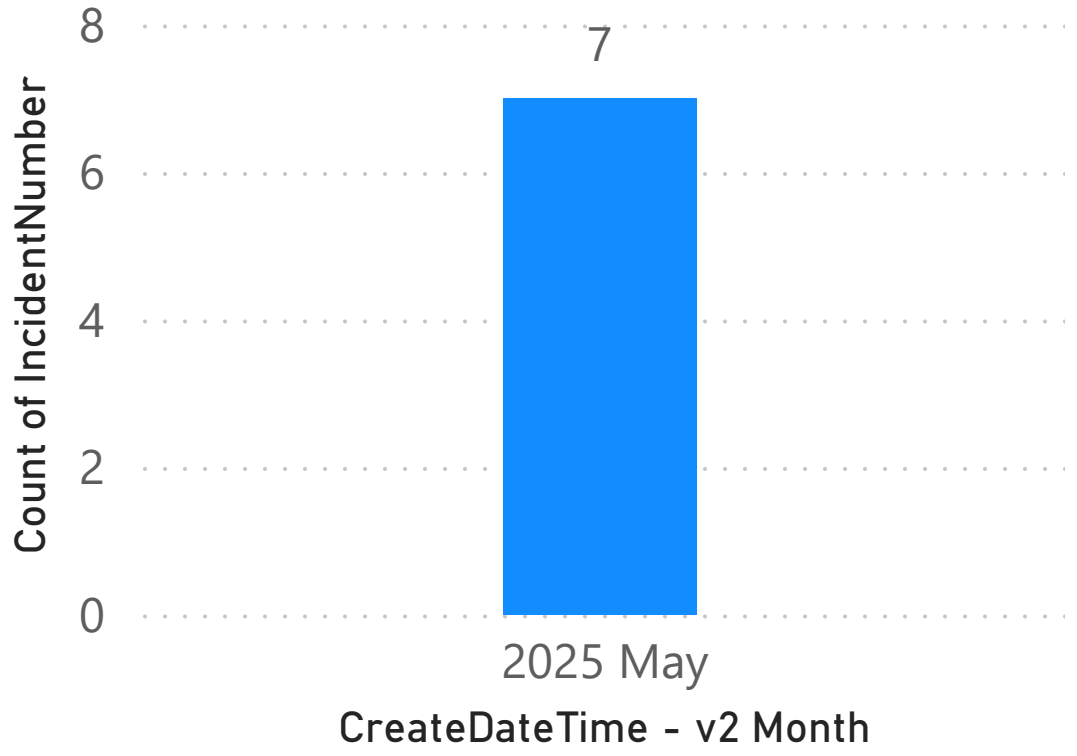


Count of CaseNumber by Year, Month and CrimeClass

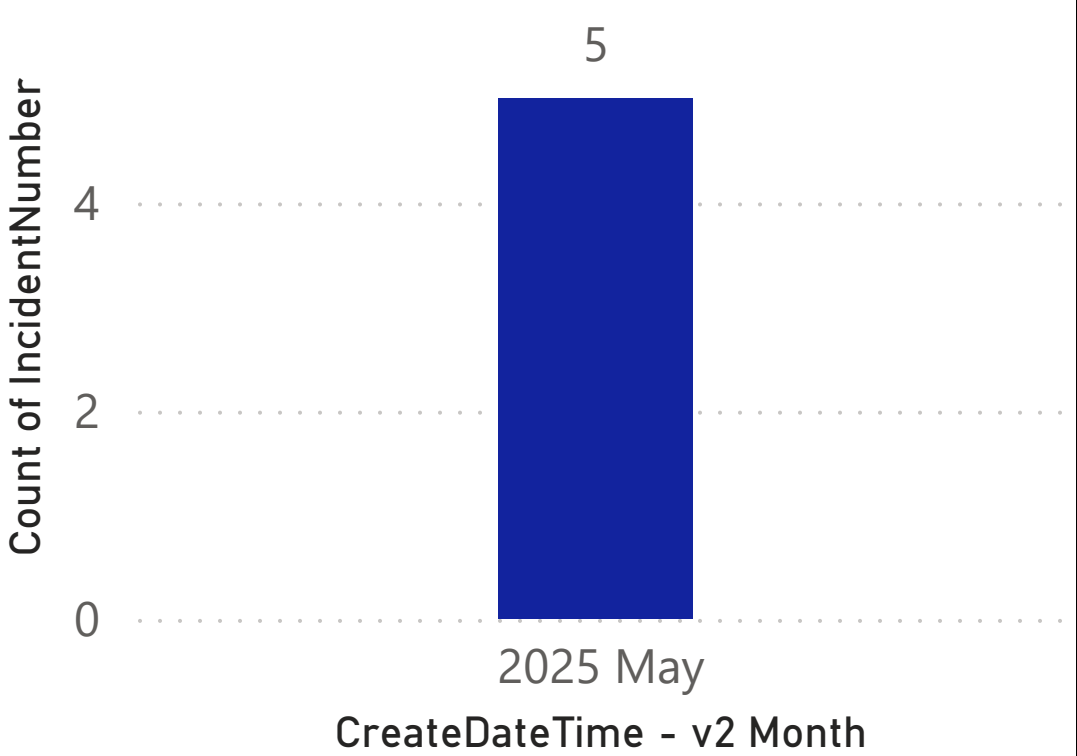

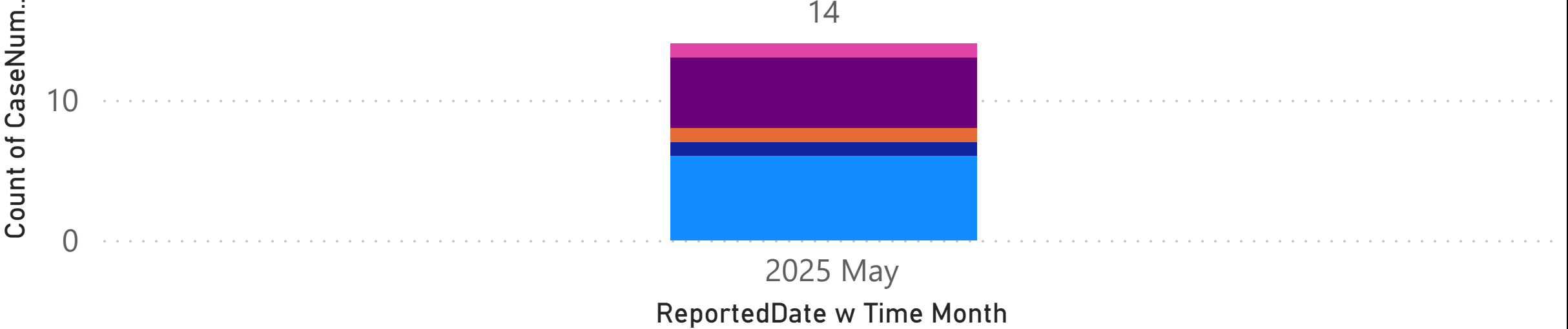

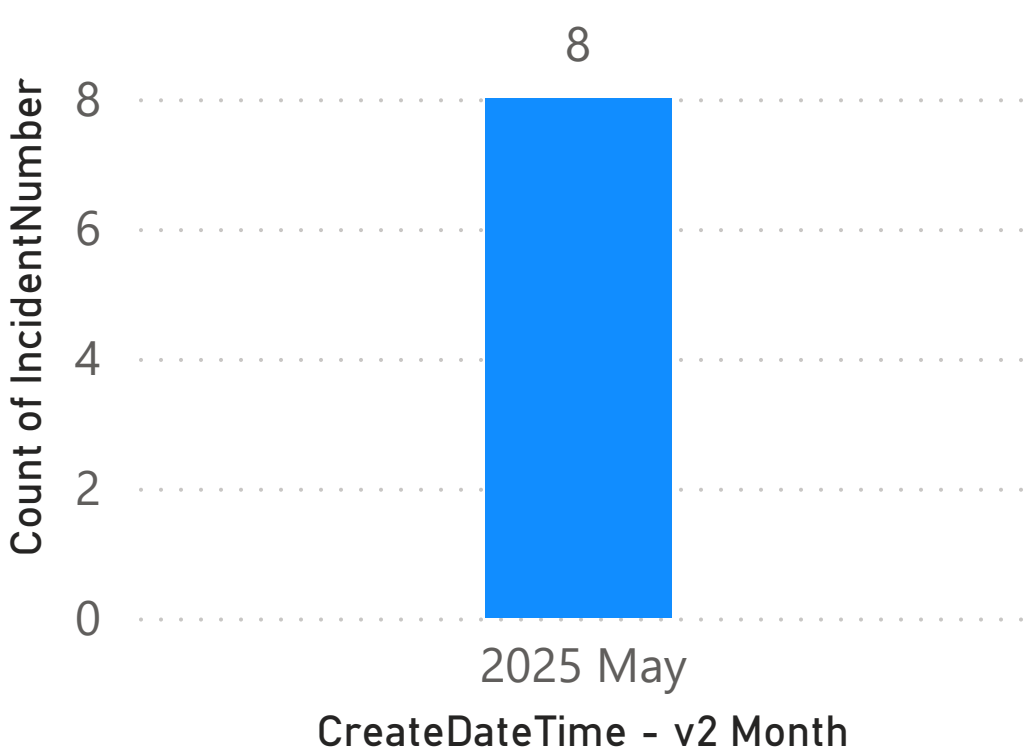


Count of CaseNumber by Year, Month and CrimeClass

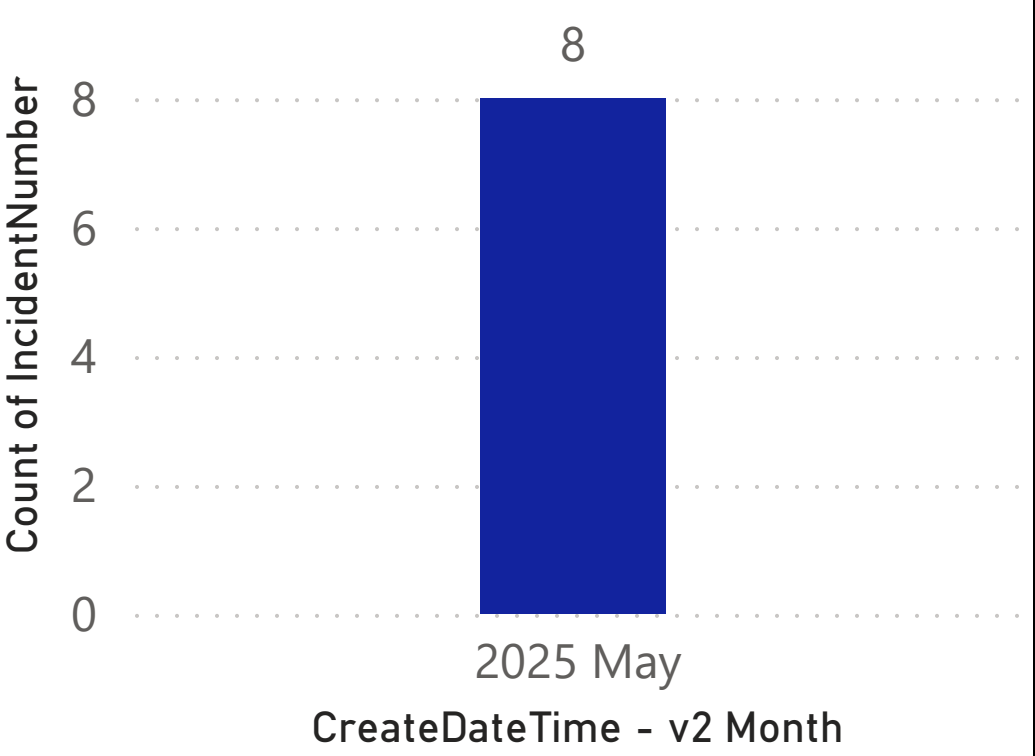

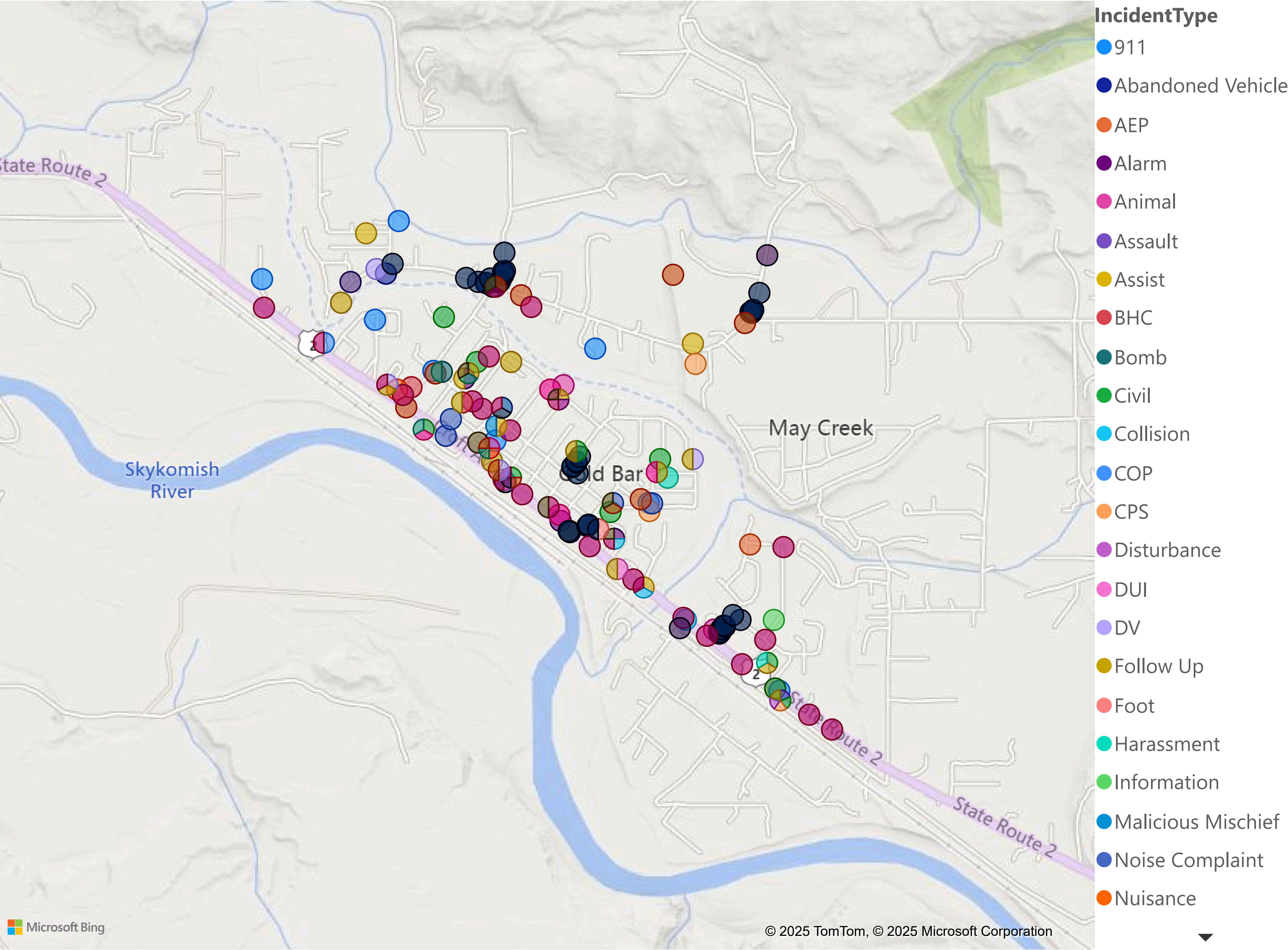

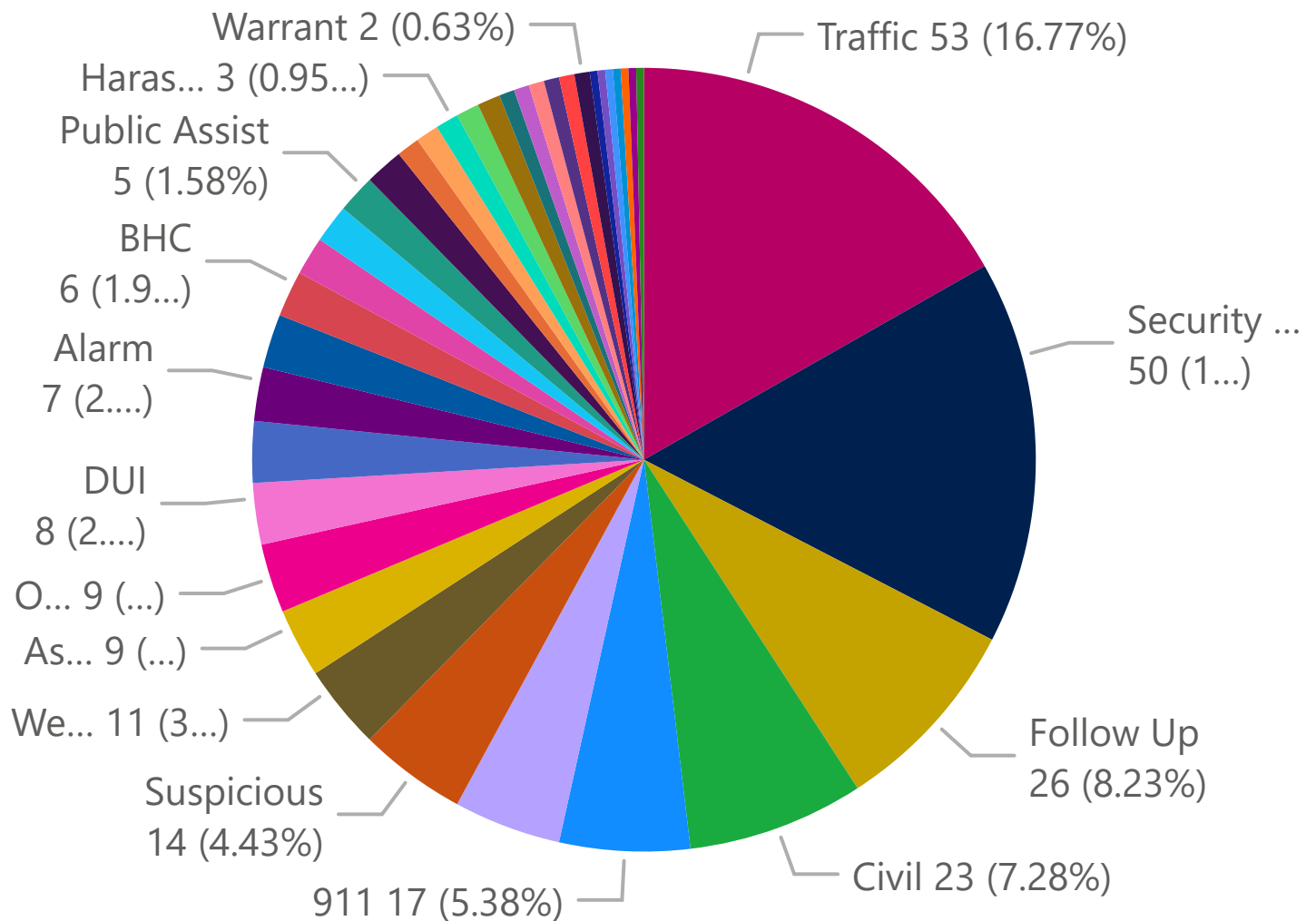

Gold Bar Incident Types - Past 12 Full Calendar Months



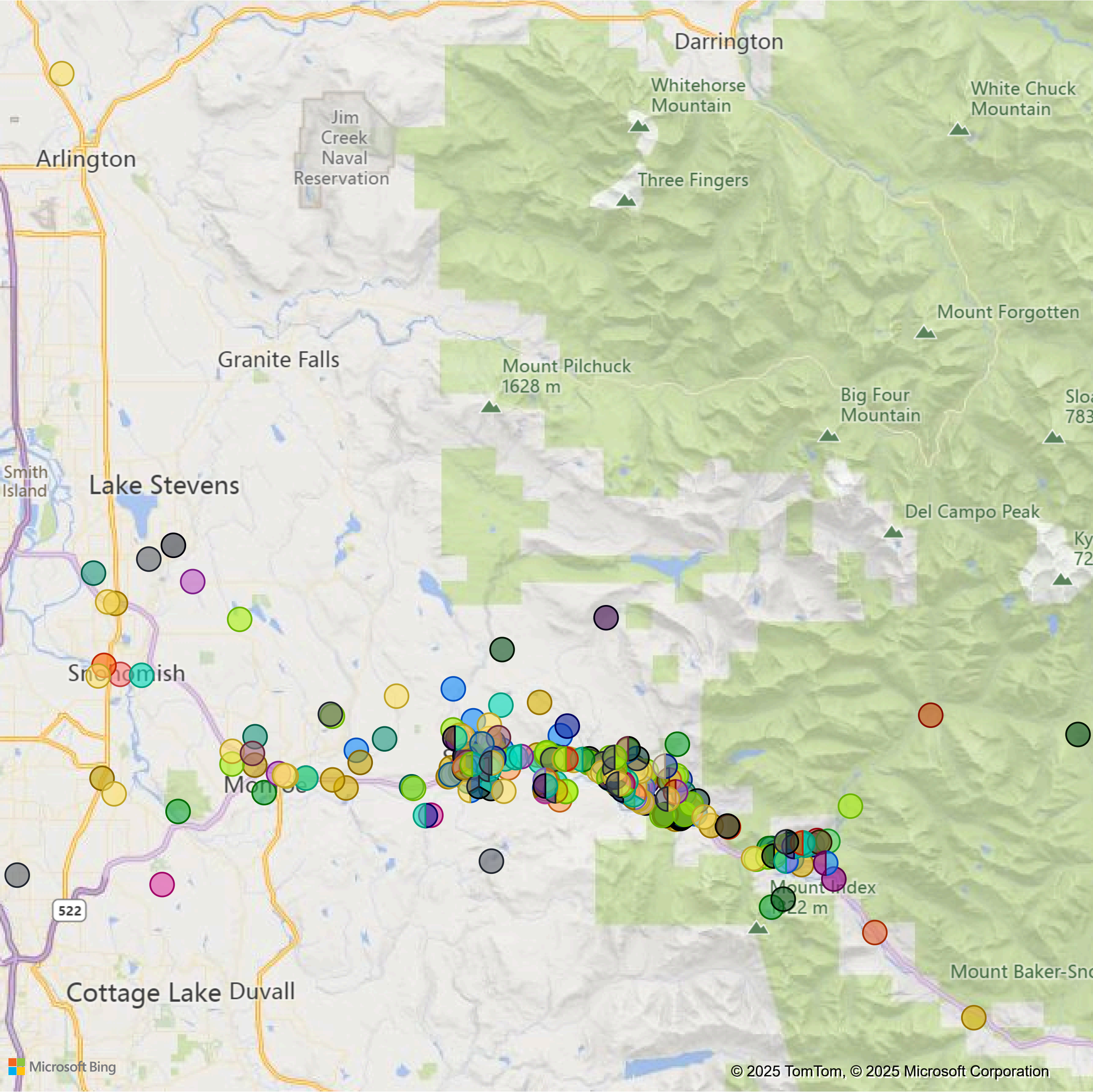
Count of IncidentNumber by IncidentType



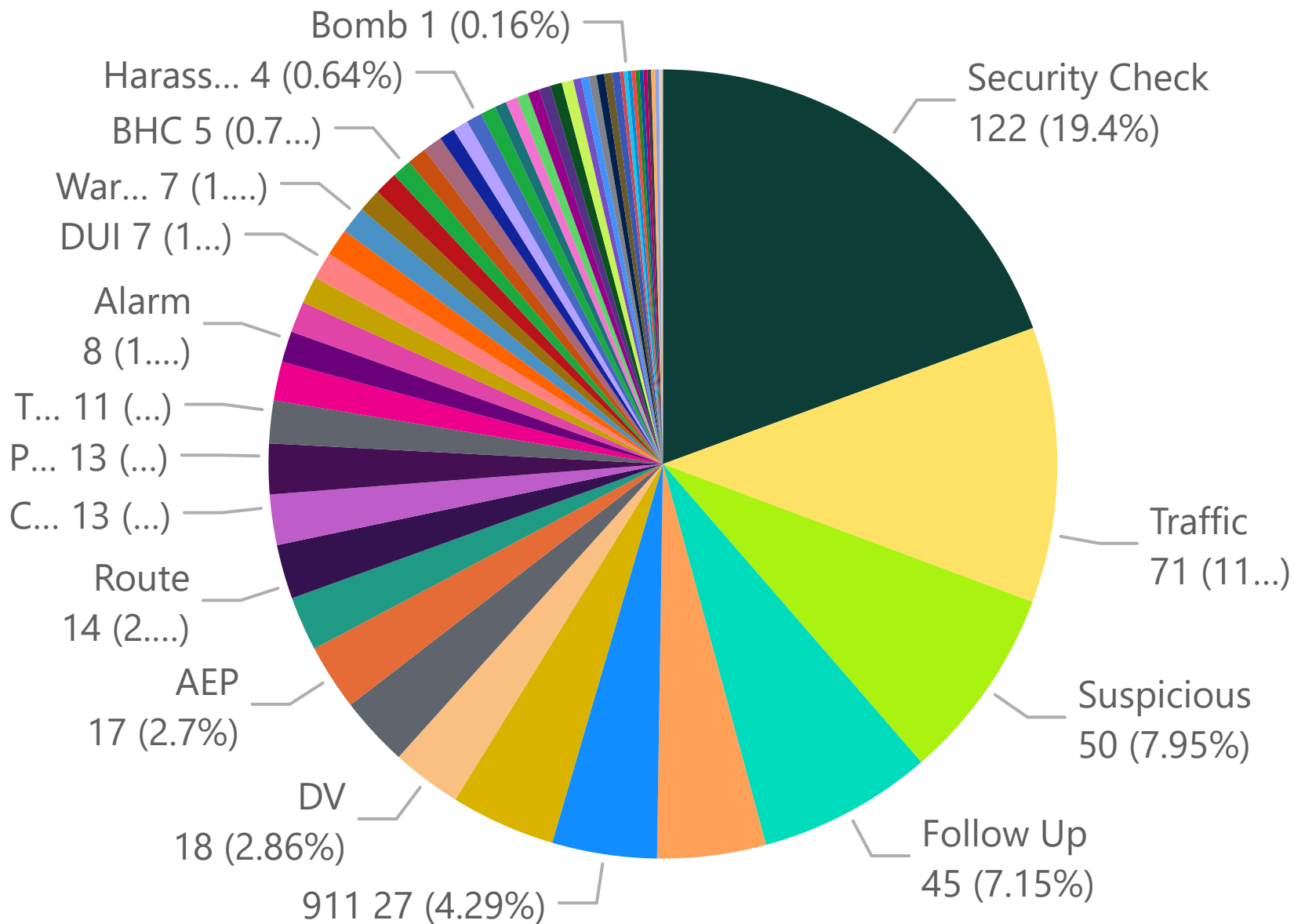
Incidents where the ORI Belongs to GBR PD Regardless of Location

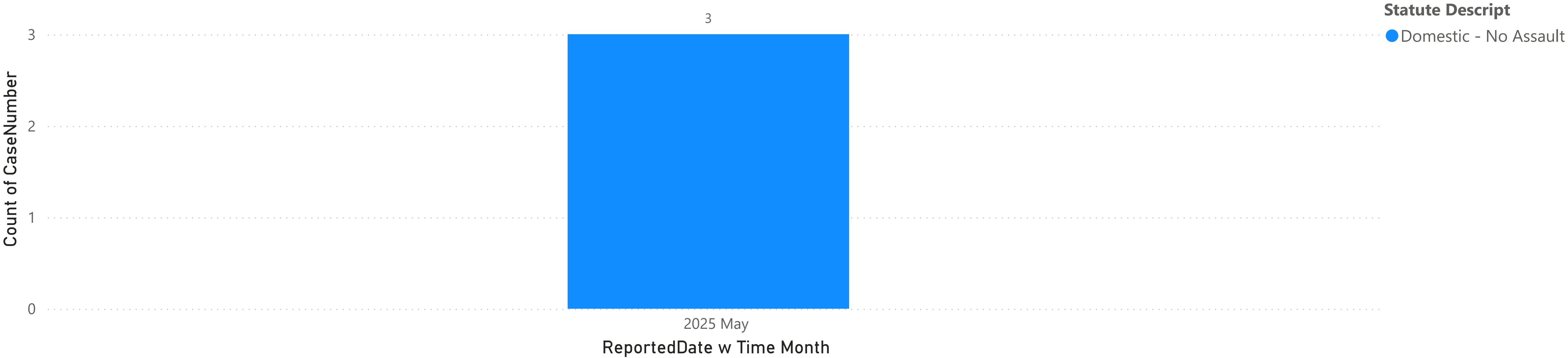
Count of IncidentNumber by IncidentType

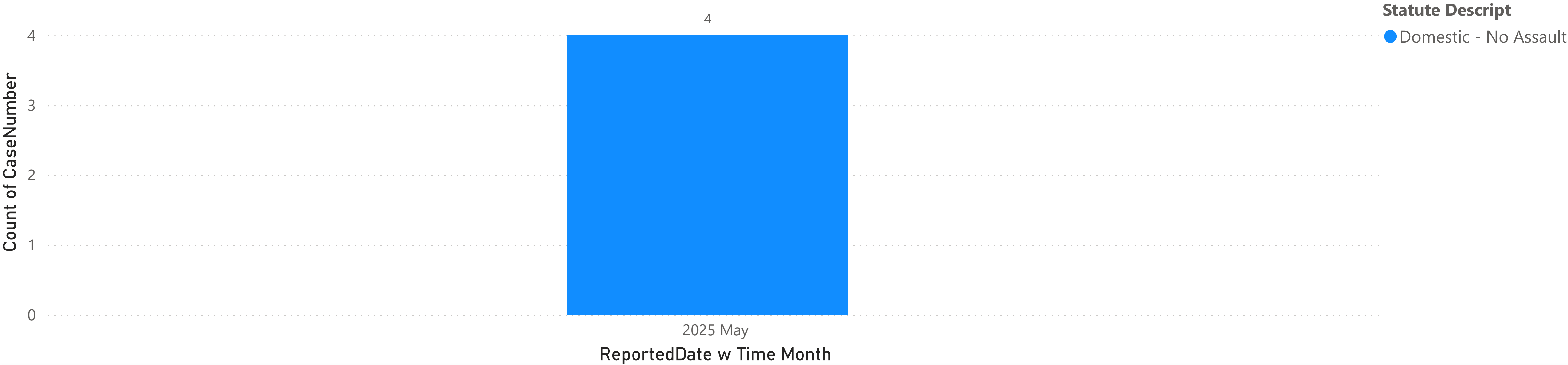
