Monthly Report to the Community for July 2025

The Month in Numbers: 7/1 to 7/31/25

- 293 Incidents in the City of Gold Bar of which 116 were deputy initiated.
- 754 Incidents in the Gold Bar Region of which 304 were deputy initiated.
- 1074 Incidents for the month of July.
- 33 Incidents per day on average

These incidents are being handled by a total staff of four Deputies and a Chief in an area of over 410 sq miles.




Highlights of the Gold Bar Police Department from this Month:


In the month of July, traffic enforcement continued to be a top priority for the department. This can be observed by the 165 traffic stops made in the Gold Bar Region.


In addition to traffic enforcement, Gold Bar deputies investigated an indecent exposure incident in the 1100 block of Croft Avenue that occurred on July 1st. The case has been referred to the Snohomish County Prosecutor's Office for a charging decision.

On July 27th, Gold Bar Deputy Sam Winningham and SCSO Sergeant Ryan Boyer with his K-9 partner Knox apprehended a DV suspect that had fled from a residence just outside the city limits on 399th Avenue SE. The rest of the story for this incident was aired by King 5 News with the release of the body worn camera (BWC) footage capturing the apprehension.





















Incidents where the Beat is GBR, Regardless of ORI

Gold Bar Incident Types - Past 12 Full Calendar Months




Count of IncidentNumber by IncidentType




Incidents where the ORI Belongs to GBR PD Regardless of Location

Gold Bar ORI, Previous 12 full calendar months






Count of IncidentNumber by IncidentType




Number of Tickets/Citations Beat GBR - regardless of ORI







