

### **Gold Bar Police Department**

#### Monthly Report to the Community for October 2025

#### The Month in Numbers: 10/1 to 10/31/25

- 269 Incidents in the City of Gold Bar of which 137 were deputy initiated.
- 626 Incidents in the Gold Bar Region of which 288 were deputy initiated.
- 895 Incidents for the month of Oct.
- 28 Incidents per day on average

These incidents are being handled by a total staff of four Deputies and a Chief in an area of over 410 sq miles.




#### Highlights of the Gold Bar Police Department from this Month:


During the month of October, the department responded to 895 calls for service and averaged 28 calls a day. Traffic enforcement continues to be a top priority for us. This month Gold Bar deputies made 52 traffic stops within city limits and 83 traffic stop in the Gold Bar Region.


On 10/18, Gold Bar deputies responded to an order violation in progress in the 600 block of Croft Avenue. The suspect in this incident fled on foot and barricaded himself in a shed. After the use of less lethal tools, the suspect surrendered and was taken into custody.

Finally, on 10/30, a Gold Bar deputy made a traffic stop just outside the city limits. During the stop, the deputy developed probable cause for possession of a controlled substance with intent to distribute and possession of a dangerous weapon. This is an active investigation.















Gold Bar Incident Types - Past 12 Full Calendar Months




#### Count of IncidentNumber by IncidentType




# Incidents where the ORI Belongs to GBR PD Regardless of Location

Gold Bar ORI, Previous 12 full calendar months






### Count of IncidentNumber by IncidentType






